2020 was a difficult year for most. As Viridiant pivoted to a remote team in early March over a year and a half ago, we have continued to work diligently to drive the delivery of affordable, sustainable and energy efficient housing when people needed it most. The world was reminded of the need for safe, efficient housing as shelter in place ordinances kept many families inside for most of the year.

Since 2006, we have been working to ensure equitable housing exists, mitigating energy burdens for some of our most vulnerable community members. Viridiant's work directly impacts a family's quality of life and utility cost savings each month through energy, water and resource efficiency. Our merger with the Richmond Region Energy Alliance in April 2020 further helped us reach the community through home energy audits and SolarizeRVA, Viridiant's community education campaign to help the Richmond region go solar.

The need for expanded programs and policy to reduce energy cost burdens, increase equity, and build more resilient communities has stayed at the forefront of Viridiant's approach over the last 15 years. Viridiant lends expertise in the energy efficiency certification of 30,000+ dwellings, increasing low-income housing supply, utility program design, energy code research, solar feasibility, financing and policy development.

Thanks to our supporters and donors in 2020, we helped put 2,619 families into homes that are more affordable, more livable and more durable. That equals 2,806 tons of carbon dioxide eliminated and over \$904,000 annual savings for these families collectively. With over a decade of experience in energy efficient construction, Viridiant prides itself on delivering services that will accelerate the shift toward high-performance buildings, clean energy, and healthy communities throughout the industry.

2020 Top High-Performance EarthCraft Home of the Year Award

BUILDER: Shelter Alternatives (HERS20)
BUILDING TYPE: Single Family Home
LOCATION: Blacksburg, VA

Each year at the Building Sustainability Conference & Awards hosted by Viridiant, the Top High Performance EarthCraft Home category assesses projects' overall improvement, notable energy performance, aesthetic improvement, and community impact. The 2020 winner was a single family home in Blacksburg, Virginia designed and constructed by Shelter Alternatives.

This single family home includes a tight building envelope and robust insulation combined with ENERGY STAR appliances and solar to achieve a **RESNET Home Energy Rating Index** (HERS) Index of 20. In addition to reducing the amount of energy needed to operate the home, there were material choices that made good use of existing resources. Trees taken down for the homesite were repurposed into trim and countertops for the home and the siding is locally sourced hemlock. The home was intentionally designed to incorporate warehousing and home offices for a home-based business and also includes a suite for an aging parent which will in turn provide future aging in place for the owners.

Viridiant is proud to recognize the hard work of Shelter Alternatives in certifying this property as EarthCraft and ENERGY STAR. "We worked closely with Viridiant in planning the details of this high performance home. Fortunately, our years of working with the EarthCraft program (since 2007) made it easier for us to meet all the criteria. The commitment of the client to also encourage us to follow a high efficiency path made it a great collaboration. Building a Pipeline of Talent

Viridiant continues to keep workforce development at the forefront as we help shape the future leaders of tomorrow by developing hands-on internships for students, providing educational offerings, and partnering with industry leaders to have a seat at the table for those important conversations around workforce development.





A robust workforce will be needed to meet the goals of the Virginia Clean Economy Act, including the goal of making Virginia carbon-free by 2050. Virginia's Department of Education has long provided "career clusters" to introduce pathways that help students explore career fields and educational opportunities. The Virginia Department of Education recently added their 17th career cluster which introduces students to the energy industry, provides information on job opportunities available to meet growing workforce demands, and develops a talent pipeline for the energy workforce.

The goal is to allow students to become interested in and aware of career opportunities in the industry and provide core skills which easily translate to industries such as architecture, construction, and manufacturing, increasing a student's options for post-secondary education and career pathways.

Viridiant's Executive Director, KC Bleile, along with Henrico County's Energy Manager, Carrie Webster, and Community Housing Partners' Director of Utility Programs, Chase Counts, were invited to contribute to the conversation around energy efficiency careers on the Henrico CTE NOW podcast. The episode discusses the efficiency and sustainability resources in Virginia and what students can look for in an energy related career as they consider the 17th Career Cluster.

Viridiant has had the pleasure of working with the University of Richmond's Bonner Scholar Program to introduce students to the inner workings of high-performance buildings. Through the program, students provide much needed additional support to local non-profits, such as Viridiant, who often operate with minimal staff and resources, while also gaining practical experience and learning and practicing the intangible soft skills necessary to succeed in today's workforce.

Viridiant is currently represented at the Steering Committee level for the Virginia Energy Workforce Consortium, which works to engage energy companies and utilities in strategic, unified, and results-oriented efforts to ensure a skilled, qualified, and diverse workforce to meet future industry needs throughout the Commonwealth.

As workforce development takes the front seat in Virginia, Viridiant will continue to advocate for the needs of the growing energy industry.

Expanding Residential Energy Code Resources

Rounding out the 3rd and final year of funding provided by the Southeast Energy Efficiency Alliance (SEEA) to assess the implementation of the residential energy code across Virginia in new construction single family buildings, Viridiant successfully conducted the Circuit Rider Program during 2020 after an unexpected pivot to a virtual delivery during COVID-19.

The team's ability to build relationships, provide technical expertise, and identify strategic areas of support for the workforce will propel Virginia forward in realizing the statewide building code."

Over the course of the 3-Year Grant Funded Project, Viridiant has:

- Trained over 1,000 industry professionals, and the number continues to increase as on-demand access to training remains available
- Pivoted in early 2020 to a fully virtual delivery and incorporated new technologies to address the needs of the remote workforce
- Built relationships with the 10 Circuit Rider participating jurisdictions and connected with over 50 jurisdictional employees
- Recognized consistent challenges faced by Building Code Departments and identified solutions to address these challenges
- Developed 14 resources for the Circuit Rider Program and circulated a total of 21 resources to every jurisdiction across Virginia
- Increased accessibility to energy code information by making resources available not only virtually, but distributed hard copies to ensure communities experiencing connectivity challenges received the information

Modeled off the Florida Circuit Rider program, the Virginia Circuit Rider Program intended to provide a one-on-one connection with building permit departments to better understand how the residential energy code is implemented, identify challenges, and develop resources to aid in enforcement and implementation.

With a goal of reaching plan reviewers and building inspectors who work directly with the residential energy code, Viridiant worked with 10 building departments around Virginia to understand their work processes and challenges encountered day-to-day. Based on this invaluable information, Viridiant developed content to address themes, challenges and gaps in available resources emphasized by the participants. Resource content ranged from HVAC, virtual inspections, duct sealing and testing, inspections and plan review around indoor air quality, insulation and air barriers, fresh air ventilation, and slab edge insulation.

Once the draft resources were completed, they were shared with the Virginia Department of Housing & Community Development (DHCD) and the participating Circuit Rider jurisdictions to incorporate their feedback as expert partners.

The resources were initially released in December 2020 to the participating jurisdictions and then in February 2021 to all jurisdictions across Virginia. Over the course of this funding project, Viridiant led a successful effort to expand the knowledgebase and available resources to aid in the residential energy code implementation and is pleased to make those freely accessible at viridiant.org/vacircuitrider.

Viridiant's Community Energy Services Division (CES) launched in April 2020 after merging with Richmond Region Energy Alliance under the Viridiant name. CES's first year saw great success with home energy audits, the SolarizeRVA campaign, and community education across the Richmond region.

The SolarizeRVA campaign emerged with a new brand this year and Viridiant is grateful for the partnerships with the City of Richmond and Henrico County to increase reach and spread awareness. Viridiant helped one family go solar in 2020 and is eager to expand on the SolarizeRVA program in the coming years.

Supporting the Delivery of Low-Load, High-Performance Buildings

Viridiant continues to focus on federal and state funding opportunities to increase the strength of Virginia's delivery of low-load, high-performance buildings and the workforce necessary to support it.

The Department of Housing and Community Development's (DHCD) Housing Innovations in Energy Efficiency (HIEE) program makes energy efficiency upgrade funding available to new and existing residential buildings to reduce energy bills for low-income Virginians. Viridiant had the pleasure of being included in the development of the HIEE policy framework with service to focus funds to address the energy efficiency needs of Virginia households through DHCD's Affordable and Special house program and the Weatherization Assistance Program. Funded through Regional Greenhouse Gas Initiative (RGGI) proceeds, the funding pool pushes projects to incorporate more ambitious energy efficiency programs for affordable housing, community flood preparedness, and coastal resilience.

Supporting clean energy advancements in the Commonwealth, Viridiant Executive Director KC Bleile served on the **Clean Energy Advisory Board**. The Clean Energy Advisory Board is established as an advisory board in the executive branch of state government with the purpose to establish a pilot program for disbursing loans or rebates for the installation of solar energy infrastructure in low-income and moderate-income households through the Low-to-Moderate Income Solar Loan and Rebate Fund.

Viridiant continued service in 2020 on **Dominion's Energy Efficiency Stakeholder Group**. Viridiant provides feedback on program design and implementation to maximize energy efficiency efforts for customers in Dominion's service territory.

Collaborative work to research and understand market potential for **Energy Efficiency On-Bill Tariff** was a focus of Viridiant over the last year. Viridiant worked closely with Rappahannock Electric Cooperative and stakeholders to explore on-bill tariff feasibility, program design, and anticipated subscription. On-bill tariff programs have the ability to finance energy efficiency improvements to homes resulting in energy savings that exceed financing costs and remain with the home.

Viridiant advocates for programs aimed at reducing energy burden and increasing energy equity. Striving to better understand the needs and service gaps for low-income households, Viridiant works tirelessly to advocate for the benefit of energy efficiency and clean energy across all communities in Virginia and to provide more resilient infrastructure and reduced energy consumption.
