# 2021 Worforce Development

In October of 2021, Viridiant, along with AZS Consulting and the Southeast Energy Efficiency Alliance (SEEA) received joint funding from the U.S. Department of Energy to work with industry professionals, manufacturers, and service providers to understand barriers to new, energy efficient technologies: air source heat pumps, heat pump water heaters, electric vehicle (EV) charging, and battery storage.

Through this work, Viridiant will help identify gaps in industry understanding and deploy resources and assistance to help ensure a more sustainable and knowledgeable workforce.







# **Expanding Code Development**

Viridiant has participated in the 2021 Residential Code development process and, in partnership with SEEA and Virginia Deptartment of Housing and Community Development, has worked to educate the industry on 2018 Residential Energy Code updates, mandated July 1, 2022.

To facilitate this work, Viridiant joined the Virginia Building and Code Officials Association (VBCOA) and actively serves as a recognized code trainer, resource developer, and educational partner. Viridiant provided tailored technical assistance to jurisdictions across the Commonwealth to aid in consistent Residential Energy Code implementation.

These opportunities allow us to continue to ensure the sustainability, safety, and energy efficiency of homes and support to our workforce in the greater Virginia area.
